### **Stop State Raids!**

n March 16, 2010, the NCCC Board of Directors voted to approve support for a county

wide petition to Stop State Raids.

The Local Taxpayer, Public Safety, and Transportation Protection Act is a constitutional amendment that we are working to place on California's November 2010 statewide ballot. The initiative would stop the state from raiding

or borrowing funding for local public safety, transportation, transit, and other essential local government services.

"State raids and borrowing of local government and transportation funds hurt our economy and business climate. The Community Development Commission of National City has been slated for \$6.2 million in state raids in the next 2 years. This directly impacts community revitalization projects, local jobs and economic development"— Jacqueline Reynoso, President/ CEO

The State recently passed a budget that borrows and takes approximately \$5 billion in city, county, transit, redevelopment and special district funds this year and the State continues to threaten to borrow or take billions in transportation funds every year. The borrowing and raiding of local government and transportation funds jeopardize our local economy:

- Raiding and borrowing local government funds hurts the services businesses rely upon and leads to increased pressure for local fees and taxes on local businesses- when local funds are reduced, it slows business development and increases pressure for local fees and taxes to pay for these services
- Raiding or borrowing transportation funds immediately harms the economy- \$1 billion spent on highway construction generates \$5 billion in economic activity and creates 18,000 jobs. Businesses rely on a reliable transportation and public transit network to move their employees to

work and products to the market.

• The State raid of \$2+ billion in redevelopment funds this year could otherwise support up to 198,000 full and part-time jobs in the construction and related industries- Redevelopment activities help support new business opportunities in local communities- when redevelopment funds are raided, it stymies job creation and business development.

The Local Taxpayer, Public Safety and Transportation Protection Act, scheduled for the November 2010 statewide ballot, would:

- 1. Prohibit the State from taking, borrowing or redirecting local taxpayer funds dedicated to public safety, emergency response and other vital local government agencies.
- 2. Protect vital, dedicated transportation and public transit funds from state raids.
- 3. Protect business development and the economy
- 4. Protect local taxpayers
- 5. Reform state government and enhance fiscal accountability

The City of National City took a huge leap forward on March 16, 2010 at the City Council meeting by approving the Westside Specific Plan, a plan 5 years in the making. The Chamber supports the Westside Specific Plan in its intention to eliminate non-licensed businesses and industrial


uses that are polluting/ nonconforming. However, we remain concerned that the Westside Specific Plan may displace some complying, nonpolluting, licensed businesses (including many of our members) that employ hundreds of people. Paramount to the Chamber is to protect the health and safety of our community, and to ensure the vitality of business operations. The Chamber's primary appeal to the City is that a Grandfather Clause be included in the Westside plan that will specifically allow fully licensed, non-polluting businesses to continue operating. "We want to ensure that job opportunities are maintained and that economic sustainability is preserved in the Westside." - Ryan Perry, Chairman Moreover, we request cautious implementation of the amortization ordinance that will allow local businesses an opportunity to address

their grievances through

a defined process, employ relocation assistance, and be treated fairly with respect to market norms.

The Chamber requests to remain fully informed and involved in the future implementation of the Westside Specific Plan in order to represent business interests and offer balanced solutions benefiting the community at large.

Southwestern College Accreditation Update



April 4, 2010

Southwestern College (SWC) welcomed an accreditation visit by the Accrediting Commission for Community & Junior Colleges (ACCJC) of the Western Association of Schools and Colleges (WASC) in October of 2009. The accreditation process evaluates all California community colleges every six years. While the Commission was complimentary of a number of the College's programs and services, and its academic growth, they noted a number of deficiencies that resulted in the College being placed on a status of probation. SWC began to address recommendations immediately after the team visit, and continues to proactively work to make the needed improvements. We anticipate that each concern will be effectively addressed well ahead of the timeline provided by the Commission.

Please rest assured that a probation status does NOT affect students' transfer credits/eligibility, degrees and certificates, academic programs, financial aid, and other student services provided to the community. SWC remains a fully-accredited institution.

We are committed to responding to each issue and reaffirming our accreditation. The SWC administration is working closely with all of our stakeholder groups, including faculty, staff, students and our Governing Board, to address each recommendation. We are working proactively together to make the needed changes and have already made marked progress.

We are very proud of our students, faculty and staff, and the quality education provided at SWC. Our students are successful when they transfer to four-year universities or upon entering the workforce. We continue to offer low-cost and effective education with limited resources. # Save Jobs Now Halt Sweetwater Union High School District Wide Layoffs

In a weak economy, pink slips have become a fact of life. This month, 23,000 public school teachers and other employees across the state were put on notice that they may not have jobs next year if proposed education cuts pass. Locally, the five school districts in the South Bay combined issued more than 650 pink slips to teachers and others. If history holds true, not all of those noticed will ultimately be laid off. But any layoffs are too many.

The City of National City is maintaining a relatively healthy financial position with respect to budget cuts, development projects, and sales tax generation. However, we are the anomaly in San Diego. Nonetheless, layoffs are a reality that we all face in the community.

Here in the South Bay, too many jobs have already been trimmed. Too many businesses have already been forced to close. Too many homes have been lost. Any more job losses would only put recovery further out of reach for some of our more distressed communities.

As business leaders we know that in order to rebuild our economy, we need to do whatever we can to save jobs. Beyond the huge personal toll on individuals and families, layoffs hurt the community in very tangible ways. Foreclosures and falling home prices have depleted the property tax base in some of South County's newest development project areas. It's those taxes that come back to local cities in the form of state funding. So when the property tax pie shrinks, state budget cuts follow and are passed along to communities in a reduction of public services.

If it weren't for National City's district tax, our community may be suffering from decreased public services as well. We have been fortunate to preserve our quality of life. However, economic sustainability must not be taken for granted. Local governments are strained to pay for essentials from libraries to fire and police protection, as well as funding

projects that have a long term return on investment. Our standard of living is only as strong as our economic base. Without jobs, thriving businesses, and a financially sound education system, our economy is weakened. With no paycheck to fill their wallets, people also lose buying power. Spending slows down to the necessities.

Belt-tightening can be painful, but some public agencies have successfully avoided layoffs by taking other steps. In National City, it's been several years since some top officials, including the city manager, have taken a pay raise. Furloughs, paycuts and job-sharing are options being used by other jurisdictions instead of cutting jobs. Anyone relying on an unemployment check will tell you that a smaller paycheck is better than no paycheck.

One important lesson of the downturn is that jobs can be saved if the pain is spread around. Businesses and local agencies are finding that when everyone shares a piece of the burden, then the brunt of the crisis doesn't need to fall on the backs of just a few. In some of our districts, labor contracts are settled. As business owners, we understand that agreements with workers need to be respected. But when both sides agree to search for solutions, talks and compromise can lead to saving jobs.

The bottom line is this: We urge teachers and district administrators to do whatever is necessary to avoid layoffs. Our school districts provide thousands of local jobs and many public school employees live right here in the community. They are our neighbors and family members. When they're out of work, we all lose.

It's Here! Beginning in March, travelers to/from San Diego International Airport will notice construction activity in front of Terminal 2 related to The Green Build, the largest project in the airport's history.

The Green Build will bring a number of long-awaited upgrades for passengers traveling in and out of San Diego International Airport. All travelers – whether visiting San Diego County on vacation, traveling on business or headed out of town on holiday – will reap the benefits of these improvements. Travelers can expect to take advantage of the finished facilities in 2013.

The Green Build Highlights:

- \* 10 new jet gates at Terminal 2
- \* A dual-level roadway at Terminal 2
- \* New, expanded dining and shopping options
- More comfortable waiting areas at the gates

In addition, the project will pursue Leadership in Energy and Environmental Design (LEED) silver certification. Goals of the project's sustainable design include:

- Decreased water usage
- Reduced energy consumption
- Use of alternative energy sources

Construction will proceed over a three-year period – at its peak, the project is expected to create more than 1,000 constructed-related jobs.

With gasoline prices still high and perhaps on the rise, as well as increasing reports about the impact of greenhouse gases on the

environment, now is the time to rethink how you typically maintain and operate your vehicles. Try following these tips to increase your fuel efficiency:

### Driving

- Consider a hybrid car that uses less gas, creates less pollution, and gets better mileage.
- Avoid idling for more than 30 seconds. Save gas by turning off your engine.
- Eliminate excess weight from your trunk and luggage racks.
- Use air conditioning conservatively to consume less fuel and decrease emissions.
- Avoid "jackrabbit" stops and starts that can dramatically reduce mileage on the highway and in the city.

### Maintenance

- Follow the recommendations for fuel octane in your manual and only use higher octane gas if it's recommended.
- Use "energy-conserving" motor oil that contains frictionreducing additives to improve fuel economy. Conform to the manufacturer's recommendation when changing oil.
- Keep your tires properly inflated to save 2-3% in fuel economy. Tires can lose one pound of pressure per month.
- Follow a preventative maintenance schedule according to your manual's guidelines to enhance engine performance.

### **Senate Passes Jobs Bill**

Washington, D.C. – U.S. Senator Barbara Boxer (D-CA) lauded the Senate passage of the HIRE Act, a bill that will create jobs by investing in transportation and providing tax credits to small businesses that hire more workers. As chairman of the Environment and Public Works Committee, Boxer helped craft the transportation provisions, which would preserve over 1 million industry jobs.

"This is a great day. Today, a million American workers

– including 100,000 in California -- know their jobs are more secure because we have renewed the transportation bill through the end of the year," Senator Boxer said. "Now that this is behind us, we will focus on moving forward with a transformational transportation authorization that will create jobs and build the infrastructure America needs for economic recovery and long term prosperity."


Majority Leader Reid unveiled the HIRE Act as the first of a series of bills designed to spur job creation. The HIRE Act will help to rebuild our nation's infrastructure through the extension of the Highway Trust Fund, which will allow for billions in infrastructure investment and has the potential to save one million American jobs. It will also extend the highly popular Build America Bonds program, which allows state and local governments to borrow for infrastructure projects at a reduced rate.

Major provisions of the HIRE Act include:

- Schumer-Hatch Jobs Payroll Tax Exemption: offers an exemption from social security payroll taxes for every worker hired in 2010 that has been unemployed for at least 60 days. There would also be an additional \$1,000 income tax credit for every new employee retained for 52 weeks to be taken on the employer's 2011 income tax return.
- Section 179 Expensing: helps small businesses grow by allowing them to write off more of their expenditures.
- Highway Trust Fund Extension: extends existing highway programs which provide states and localities with the certainty they need to make decisions on projects. It allows for billions more to be invested in infrastructure throughout the nation and saves one million jobs.
- Expanding Build America Bonds: allows state and local governments to borrow at lower costs to finance more infrastructure projects and put people to work.

### Free Help Available For Your Business

In today's challenging economic climate, South County employers can benefit from federally subsidized programs available now. The South County Economic Development Council (SCEDC) wants to ensure that businesses are aware and take advantage of these programs provided by a new initiative with the San Diego Workforce Partnership.

### SCEDC can:

- Help businesses determine how to qualify to receive federal tax incentives such as the Work Opportunity Tax Credit, and Enterprise Zone Tax Credits.
- Assist companies facing layoffs by presenting a toolkit of services to employees including the opportunity to talk with unemployment insurance benefits representatives, engage in networking opportunities, obtain access to free or low-cost training, and enroll in various workshops to prepare employees for career transitions.
- Provide staff recruitment assistance and assist employers in writing job descriptions and posting job openings for free on an online statewide job search engine.
- Facilitate recruitment by hosting hiring events at the South County Career Center, a partner agency.
- Through its partnerships with Vet-Works and Able-Disabled Advocacy, refer pre-screened qualified job applicants to employers interested in hiring discharged service men and women, and individuals with a disability.

Additionally, SCEDC can direct employers to subsidized job training programs for new staff. One program, On-the-Job Training (OJT), allows businesses to be reimbursed for up to 50% of the wages or salaries earned by new hires during their training period. Another program, Customized Training, is designed for companies in expansion mode. This program funds up to 50% of an employer's training costs to train new employees.

### National City Awarded \$1 Million for Brownfield Revolving Loan Fund

A Revolving Loan Fund for commercial and industrial properties contaminated by hazardous materials has been established in National City, thanks to a \$1 million grant from the US Environmental Protection Agency ("EPA"). The Fund is being administered by the Redevelopment Division at City Hall.

"The Brownfield Revolving Loan Fund is a useful tool for eligible property owners," said Patricia Beard, the city's redevelopment manager. "Loans can be custom-tailored to assist cash flows for projects. Extremely attractive interest rates can be offered, with incentives for early repayment. The program objective is for loans to be repaid within less than five years."

The funds are available for the clean up of hazardous materials and petroleum. "These loans are perfect for eligible property owners who already have a remediation plan under review or approved by the City, County or State," Beard said. Demolition and/or abatement of lead or asbestos are eligible projects for consideration. No minimum loan amount is required and loans can be as large as the current fund balance, which sets aside \$800,000 for clean up of hazardous materials and \$200,000 for clean up of petroleum. The City Council will approve all loans, which

must be used on properties in National City.

Non-profit organizations may qualify for sub-grants from the City if they are the property owners of eligible sites. In order to be eligible for a loan (or sub-grant for non-profit entities) certain specific due diligence activities must have occurred for properties acquired later than October, 2006. Successful applicants cannot be the parties responsible for the contamination.





### **HR Tips Provided by Employer's Group**

1. Can employers dock an exempt employee's wages for time spent on jury duty regardless of the number of weeks on such duty?





2. Can I dock exempt personnel's pay in hourly increments?

No. To do so would threaten the exemption.

3. If an employee reports to work and there is no work available, are there special pay requirements?

The employee shall be paid for half the usual or scheduled day's work, but in no event for less than two (2) hours nor more than four (4) hours, at the employee's regular rate of pay.

- 4. Can an employer deny a FMLA day to an employee who has an existing medical certification under FMLA? No, provided that the medical certificate specifies intermittent leave.
- 5. Once an employee has a FMLA certification does the Department of Labor (DOL) allow the employer to request re-certification?

Yes, you may request a new certification every 30 days, but not more frequently unless there is a change in the employee's condition. If the health care provider puts the employee out for more than 30 days, you may request recertification only after that time expires. A recent DOL opinion letter states that you can request a new recertification annually.

- 6. Must employees have one day a week off? Yes, but it can be averaged out over a month's time. In other words, they must have at least four days off per calendar month.
- 7. What are the maximum hours an employee is allowed to work in one 24-hour workday period?

There is no maximum number of hours. Exceptions exist

for special occupations, i.e. airline pilots, and class A commercial truck drivers.

8. If the employee withdraws a sexual harassment complaint does the employer continue with the investigation?

Absolutely, company liability is still possible if an investigation is not done. Once an allegation has been made, an employer is "on notice" and must investigate.

9. When an employee guits, how much time does an employer have to furnish the employee with the final check?

A resigning employee who provides at least 72 calendar hours of notice must be paid at the time of quitting. If an employee quits without giving notice, an employer must make payment within 72 calendar hours.

10. Is it permissible to pay a discharged employee his/her final check on their next scheduled payday?

No, a discharged or laid-off employee must be paid all earned wages immediately including accrued vacation pay immediately on termination. (Special rules apply to certain seasonal employees, motion picture employees and oildrilling employees.)

# Update to Countywide ATM Theft Security Precautions for Businesses

From January 23rd to March 4th 2010, there have been fourteen thefts or attempted thefts of ATMs throughout San Diego County. Two of these incidents occurred in National City (February 8th and 18th). Historically,

National City averages two ATM thefts a year.


Detectives from law enforcement agencies throughout the county have been meeting and comparing notes from their respective cases in a concentrated effort to solve this crime series.

Here are some preventative measures businesses can take to help deter future ATM thefts.

Location of the ATM: All too often, the targeted ATM is placed too close to the front door which presents thieves with easy access. A suggestion would be for businesses to place the ATM machines deeper into the business or shopping mall, and place benches or other types of displays between the ATM and front door.

ATM Display Itself: Many times, ATMs within businesses

are poorly secured, stand-alone machines. Within a short period time (sometimes seconds), thieves are able to knock over or dislodge an ATM by chaining it up and pulling it out with a vehicle, or simply pushing it over on its side and carrying it away. A suggestion would be for businesses to require ATM



Lack of ATM Security Measures:

Although tracking equipment similar to "LoJack" for ATMs exists, ATM owners oftentimes do not install such equipment. The most common reason cited is the cost. ATM owners tend to buy the lowest costing ATM and then only stock the ATM with a couple thousand dollars. Unfortunately, when a vehicle smashes through the front of a business to steal an ATM, the perception for the whole area now becomes one of danger and shoppers end up going elsewhere – which affects all businesses in the area. There are tracking devices that can be installed in ATMs for about \$500. When used, these devices often lead to the quick arrest of the thieves.

Additional precautions include implementation of surveillance video, private security, and National City's Business Liaison Program.

The National City Police Department is in the second year of its Business Liaison Program. The focus of this program is to enhance the partnership with City Government and


